This survey was carried out on behalf of the Committee on the Rights of the Child. They are producing a report (called General Comment) to set out what governments need to do to make sure that all the rights in the Convention on the Rights of the Child are being respected for all adolescents around the world. Once the report is finished, it will provide guidance for every government (except the USA which has not signed up to the Convention on the Rights of the Child) - and they will be expected to take account of it in the way they develop laws, policies and services that affect young people's lives.

This questionnaire for young people aged 10-17 was developed in partnership with adults and young people during a workshop held in CATS 2015.

The questionnaire was then published in English, French and Spanish by Child to Child across social media platforms.

- Lack of recreational facilities. Traffic too busy causes air pollution. Lack of public transport.
- In our area violence is very high so sometime my parents are scare to send me for the play
- Nowhere to go Insecurities in body image
- Can't arrange without support from parents
- I don't have time to see my friends. I'm always at trainings and have absolutely no free time. Wake up, go to school, go to training,get home, do homework, sleep. This will be my schedule till I get 16, until then my parents deside what to do with my free time.
- Lack of facilities
- my gender...... i'm a girl and i'm not really "allowed" to play with the boys either because it's too unsafe or i'm just judged badly because i'm a girl
- Over generations we have become more protective of children to the point of smothering them. E.g. British Bulldogs while it was physically it was fun for kids and we got dirty, muddy and knackered. Now it's banned. Some schools having even banned football and this carries on to out of school.
