

The role of ombudspersons, mediators and other national human rights institutions (NHRIs) in the promotion and protection of human rights

This submission is made on behalf of the Child Rights International Network - CRIN (www.crin.org), 24 April 2017.

The Child Rights International Network is a global research, policy and advocacy organisation working on the human rights of children. This submission will focus on national human rights institutions dedicated to children or with mandates covering children. In 2016 we published global research on access to justice for children

(<u>www.crin.org/home/law/access</u>) including analysis of NHRIs in 197 jurisdictions, including all UN member states. Statistics included in this submission draw on this research.

This submission is intended to give a brief overview of the prevalence and powers of NHRIs for children globally, but we would be able to provide more detailed information if this would be useful in preparing the report.

Question 1

Do you consider that an independent and autonomous ombudsman, mediator or other national human rights institution has been created or strengthened at the national and, where applicable, the local level in your country?

Our research found that 130 countries have a national human rights institute that has a mandate broad enough to cover children's rights, whether in the form of a national human rights commission, ombudsperson, children's ombudsperson or another form of independent body that can address human rights more broadly. Only 83 States have child specific NHRI, a department within a broader NHRI or a position within the NHRI specifically for children.

129 States have a NHRI empowered to receive complaints or pursue a complaint through the courts.³ See question 4 below for examples of how these mechanisms can be designed to enforce human rights. According to our research, 73 NHRIs have a mandate that includes reviewing the State's progress in realising children's rights, whether expressed as a power to review compliance with human rights in general or ratified international treaties specifically.

Question 2

Is the ombudsman, mediator or other national human rights institutions endowed with an adequate constitutional and legislative framework, as well as financial and all other appropriate means in order to ensure the efficient and independent exercise of the ombudsman's mandate and to strengthen the legitimacy and credibility of its actions?

Our research did not analyse all of the issues covered in this question, but did examine appointment procedures, considering whether they were transparent. Of the 130 countries with NHRIs, we considered that only 82 had an appointment procedure that was broadly

transparent. In making this determination, we excluded institutions where commissioners or ombudspersons were unilaterally appointed by the relevant president or prime minister without additional review or oversight.

Question 4

<u>Please share best practices on the work and functioning of the ombudsman, mediator or other national human rights institutions in your country.</u>

Complaint mechanisms within national human rights institutions or the power for NHRIs to launch legal proceedings to protect rights can be among the most effective means of using these bodies to protect the human rights of vulnerable groups, particularly children. These mechanisms vary significantly in terms of their scope and effectiveness. The examples given below are illustrative of the ways that national human rights institutions have been empowered to address complaints and some of the key features of these mechanisms and are by no means exhaustive:

- Constitutional rights protection. Public Defenders in Georgia for example, can receive complaints that state, local government authorities, public institutions or officials have violated the rights provisions of the Georgian constitution. The Public Defender of Kyrgyzstan has a similar power, as well as the authority to appeal to the Constitutional Chamber of the Supreme Court to declare unconstitutional laws concerning human rights.
- Class actions. Fiji's Human Rights Commission,⁶ the New Zealand Director of Human Rights⁷ and Ireland's Human Rights and Equality Commission⁸ all have a similar power to bring proceedings on behalf of a class of persons to vindicate their human rights.
- Anonymity for victims. Human rights bodies in Scotland, Northern Ireland, Ireland and Slovenia, among others, can initiate court proceedings in their own name without identifying a victim.⁹
- Intervention in cases affecting human rights. The Ombudsman for Bosnia and Herzegovina is empowered to intervene in ongoing cases where he or she considers that the relevant administrative act constituted a human rights violation.¹⁰
